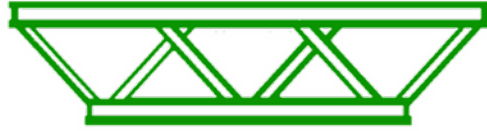

Zinc Raw Materials

Only high purity zinc of above 99.995% is used for the galvanizing and is procured from world well-known manufacturers. The same thing is considered in the case of acids and other chemicals.



Inspection and Testing

In **Technosteel Coatings** plant, the temperature of the molten zinc is constantly monitored through automated Controlled Devices and thermocouples. The inspection team conducts thorough inspection and records the results at various stages of the process as required. The products are sent to an independent laboratory on a regular basis for analysis-thereby ensuring the quality of the finished materials.
